DIRECTIONS: Long standing habits are harder to break so initial applications need to be frequent and heavy. Always remove fecal matter before treating the affected area. Generously sprinkle granules in and around the area you want dogs and cats to avoid. For digging problems, work the granules into the top 2 inches of soil or mulch and complete with a top dressing of repellent. Initial application rate: 1 lb/25 sq ft. Once habits are broken, reapply as needed to maintain avoidance, usually every 1-3 weeks. Maintenance application rate: Up to 1lb/100 sq ft. Application rates will vary depending on weather conditions and animal population. Reapply after frequent or heavy rainfall.

I Must Garden Dog & Cat Repellent is available as a liquid spray to address chewing and gnawing on plants, garden hoses, outdoor furniture and more. Both the granular and liquid repellent may be used together to address multiple problems with dogs & cats. Please check for odor acceptability and staining possibility when using indoors.
